

**ZIPLOC® WAREHOUSE CLUB SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

The Ziploc® Warehouse Club Sweepstakes ("Sweepstakes") is sponsored by S.C. Johnson & Son, Inc. ("Sponsor"), 550 W. Washington, Suite 1400 Chicago, IL 60661, and is administered by Prize Logic, LLC ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI USA 48033.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on July 1, 2019 at 12:00:00 PM Eastern Time ("ET") and ends on September 30, 2019 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States, the District of Columbia, and Puerto Rico, who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, Sam's Club, BJ's, and each of their respective parent companies, subsidiaries, affiliates, officers, governors, owners, distributors, retailers, advertising and promotion agencies, and companies involved in the implementation and execution of the Sweepstakes (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address. Winning a prize is contingent upon fulfilling all requirement set forth herein. Entrants and/or potential winner may be required to provide proof of identification and eligibility as required by Sponsor or Administrator.

3. **HOW TO ENTER THE SWEEPSTAKES:** There are two (2) ways to enter the Sweepstakes:
  - A. **Make a Purchase:** During the Sweepstakes Period, an eligible entrant may purchase any one (1) eligible Ziploc® brand product (see Appendix for list of eligible products) from any participating BJ's or Sam's Club in the United States, the District of Columbia, or Puerto Rico, ("Qualifying Purchase"), while supplies last. Entrant must then visit [www.club.winziplocstem.com](http://www.club.winziplocstem.com) ("Website") and follow the links and instructions to complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, and date of birth. The entrant must then follow the on-screen prompts and upload a photograph of the original receipt showing the Qualifying Purchase. The file must be in .JPEG, .JPG, .PNG, or .GIF format (no PDFs will be accepted) and may not exceed 8 MB. Entrant must also select the store (particular BJ's or Sam's Club) where his/her Qualifying Purchase was made and provide his/her child's school name, address, city state and ZIP code as well as his/her child's grade. A receipt may not be submitted more than one (1) time. Digital receipts will not be accepted. Duplicated receipts will not be accepted. Receipts must be readable. Mechanical reproductions, altered receipts or unreadable receipts will not be accepted. Receipts submitted in excess of the limits set forth herein will not be accepted. Following this method of entry, an entrant will receive one (1) entry into the applicable pool ("Pool")

based on the store where entrant made the Qualifying Purchase. There will be a total of eight hundred six (806) Pools, one (1) for each participating store. There are five hundred eighty-nine (589) Sam's Club warehouse stores and two hundred seventeen (217) BJ's stores. There is a limit of one (1) receipt upload during the Sweepstakes Period.

**B. Enter Without Making a Purchase:** To earn a Sweepstakes entry without making a purchase, an entrant may visit [www.club.winziplocstem.com/Amoe](http://www.club.winziplocstem.com/Amoe) and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, and date of birth. Entrant must also select a store (BJ's or Sam's Club) closest to his/her residence and provide his/her child's school name, address, city state and ZIP code as well as his/her child's grade. Upon completion and submission of a valid registration, the entrant will receive a code via e-mail. Entrant can only receive one (1) code during the Sweepstakes Period. Entrant must then visit the Website listed above ([www.club.winziplocstem.com](http://www.club.winziplocstem.com)) and follow the links and instructions to complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, date of birth, and valid code to receive one (1) entry into Pool based on the participating retailer select upon registration.

**Limit:** Regardless of method of entry, an entrant will receive no more than one (1) entry during the Sweepstakes Period. If more than the stated number of entries are received from the same person, telephone number and/or e-mail address, the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor's sole discretion, may not be eligible to win a prize. Subsequent attempts made by the same individual to submit multiple entries by using multiple or false contact information, accounts or otherwise may result in the entrant being disqualified. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. **Special Offer:** During the Promotion Period, upon uploading a valid receipt or submitting a valid code, each entrant will have access to unlock activities on the Website. There will be sixteen (16) possible activities total. An entrant may only unlock activities when he/she uploads a valid receipt or enters a valid code.

**4. RANDOM DRAWING:** On or around October 1, 2019, the Administrator will randomly select one (1) potential winner from all eligible entries received for each Pool for a total of eight hundred six (806) potential winners. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

**5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:**

**A. Prizes (806 total; 1 per Pool):** Each winner will receive a KiwiCo Prize Pack that includes materials sufficient for twenty-five (25) students to each execute the same project, for winner to share with a local school classroom (each a “Prize”). The ARV of each Prize is \$498.75. No more than one (1) winner will be selected from each Pool for a total of eight hundred six (806) Prizes.

**B. Total ARV of All Prizes:** The total ARV of all Prizes is: \$401,992.50.

**C. Odds of Winning:** The odds of winning a Prize depend on the number of eligible Sweepstakes entries received for each Pool during the Sweepstakes Period.

**D. General Conditions:** In no event, will more than eight hundred six (806) Prizes (one [1] per Pool) be awarded. A Prize that is unclaimed, unredeemed, or returned as undeliverable will not be awarded. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS**

**RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
